Notice to California Residents

The following section applies to California residents.

(a) *Shine the Light*. Under California's "Shine the Light" law, you have the right to ask us once a year if we have shared your personal information with third parties for direct marketing purposes. (b) *California Consumer Privacy Act* ("CCPA"). The CCPA creates consumer privacy rights and requires businesses to make disclosures about their privacy policies and practices. - *Right to Delete.* You may request that we delete certain personal information we have collected about you, with certain exceptions.

We may not discriminate against you if you choose to exercise your rights.

<u>Responding to Your Rights Request</u>. We will try to respond to your request within 45 days. If we need more time, we will contact you with the reason we need more time and the extension period. If you have an account with us, we will deliver our written response to that account. If you do not have an account with us, we will deliver our written response by mail or electronically, at your option. In response to your request to know, we will only disclose the

information we have collected in the 12 months prior to our receipt of your request. Our response will also explain the reasons we cannot comply with any request, if applicable.

We do not charge a fee to process or respond to your request unless your request is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate prior to completing your request.
